DIRECTIONS FOR FOGGING For ULV. fogging: Dilute concentrate with one part water and fog as directed. For wet foggers: dilute 12 ounces Floral Carpet & Fabric Odor Counteractant to one gallon water.

Note: Some breathing irritation may be present when fogging. Use of a respirator is suggested.

Other Uses: Add directly into cleaning solutions as needed to control and eliminate odors. 1 to 3 ounces per gallon added to cleaning solutions, 2 to 8 ounces per gallon for direct spray.
